TERMS AND CONDITIONS

CHRISTMAS AT THE RACES "ENQUIRE & WIN" COMPETITION 2021



- All Entrants ("Entrants") who participate in this Competition (the "Competition") are
 deemed to accept these terms and conditions of entry. Entries that do not comply with these
 terms and conditions will be deemed invalid and the Wellington Racing Cub ("WRC") takes
 no responsibility for such entries. All times given in this terms and conditions are references
 to New Zealand Local Time and all references to currency are referring to New Zealand
 Dollars.
- 2. The Competition Entry Period opens at 5:00PM on Monday 14th June 2021 and closes at 12:00PM on Saturday 31 August 2021 (the **"Competition Period"**).
- 3. To be eligible for entry into this Competition, an Entrant must:
 - Be eighteen (18) years of age or over from the time the Entrant first participates in the Competition during the Competition Period; and
 - Before the end of the Competition Period have made a enquiry or booking for Christmas at the Races 2021 event via wellingtonracing.co.nz or by contacting a member of the team at Wellington Racing Club.

- 4. The WRC reserve the right to require any Entrant to produce identification to verify his or her age.
- 5. There is a limit of one (1) Competition Entry per person.
- 6. Excluded customers of WRC are not eligible to win prizes.
- 7. On Tuesday 3 September 2021, a random draw will be conducted in the presence of a designated WRC Representative (the **Prize Draw**). The final decision in respect of any winning entries will be at the sole discretion of the WRC and no correspondence will be entered into.
